

## Pet Contract

This agreement governs the Sale of the following Cat

BREED COLOUR SEX BIRTH SIRE DAM

The purchase price of cat described above is \$

Purchaser accepts the responsibility of caring for this cat, will provide properly for its welfare and agrees to provide a clean and pleasant environment, not caged, with proper nutrition and vet care. This cat will be kept indoors and not declawed.

This cat shall not, under any circumstances, be sold, leased and/or given to any pet shop, research laboratory, humane society and/or any similar type of business.

In the event the purchaser cannot or chooses not to keep this cat for any reason, it must first be offered back to the breeder at no cost.

Purchaser agrees to have this cat examined by a veterinarian within 5 days of receipt and must notify the breeder within 48 hours of any adverse findings. If this cat is found to have an untreatable or life threatening illness by the veterinarian, documentation must be provided and the breeder must be notified immediately.

All veterinarian costs are the responsibility of the purchaser. The breeder is not responsible for any veterinarian bills.

Purchaser is aware this cat has been examined by a licensed veterinarian two times at their 8 and 12 week vaccination appointments and was found to be in good health.

Purchaser is aware this cat has been vaccinated two times for fvrcp at 8 and 12 weeks of age. Purchaser is also aware this cat will be due for one fvrcp vaccine and one rabies vaccine at 16 weeks of age (4 weeks after the last vaccine) and this will be the responsibility of the purchaser to have done with their veterinarian. Purchaser agrees to never have this cat vaccinated for Leukemia.

Purchaser agrees to have this cat spayed/neutered no earlier than 5 months of age and no later than 8 months of age and understands that this spay/neuter agreement is binding and enforces that this cat will not produce a litter of kittens via on purpose or accidental.

Purchaser must send proof of spay/neuter to the breeder within 10 days following the surgery. It is the responsibility of the purchaser, not the veterinarian, to ensure that the breeder has received appropriate documentation stating that the surgery has been completed.

Purchaser understands the breeder will hold this cats registration papers until they have received proof of spay/neuter. Once proof has been given, the breeder will release said cats registration papers.

This cat is guaranteed until 1 year of age against congenital defects if this cat should pass away. A veterinarian necropsy must be completed and a signed report must be provided to determine the cause of death. This cat will be replaced with another cat as available, at the discretion of the breeder. There are no cash refunds under any circumstance.

Purchaser agrees to activate the Trupanion Pet Insurance trial today that has been provided.
